

## Terms and conditions of the Bike Rental in the Tourist and Cycling Information Center

- **1.** Terms and Conditions these regulations describe rules of use, conditions and scope of rights, which acceptance is a prerequisite to use the Bike Rental which belongs to Tourist and Cycling Information Center. Along with acceptance of the rules, it becomes a Contract between the Borrower and Wigor Advertising Agency.
- **2.** Bicycles are owned by Wigor Advertising Agency, Sokolnicza 34-38 Street, 53-6660 Wrocław, represented by Tourist and Cycling Information Center, located on Św. Antoniego 8 Street, 50-073 Wrocław.
- **3.** Bike Rental is opened every day during the working hours of Tourist and Cycling Information Center, from 9.00-20.00
- **4.** Bicycles are equipped with lights (front and back), carrier, mudguard, bell, helmet, visibility gilet, padlock with one key.

## 5. To rent a bike following conditions must be met:

- borrower must present a valid identification with a photo, which will be a basis to create a contract and its copy
- borrower must sign the contract of the bike rental and be acquainted with the Terms and
   Conditions of bike rental, accept them and obtain ta fully functioning bike.
- in case the Borrower is under age (less then 13years old) a bicycle licence is essential to present
- borrowers under 16 years old have a right to rent a bicycle only with the permission of an adult who is a legal guardian of the under age. This person takes total responsibility for the rented bicycle and the person who is using it.
- borrower can't be under the influence of/impaired by alcohol, intoxicants, psychotropics
  or any other drugs in accordance to the anti-drug legislation which describes the health
  conditions for the users of the vehicles.
- borrower must pay a refundable deposit of 100PL.

## Borrower is obliged to:

- use of the bike and its equipment according to its application
- return undamaged and functioning bike and its equipment by the time and date as stated
  on the Contract. Time is rounded up to 15 minutes to Borrower advantage. Bike has to
  be returned to the place of rental, which is Tourist and Cycling Information Center on
  św. Antoniego 8 Street, 53-660 Wrocław.
- use the bike for personal use only, commercial use is prohibited
- not give the bike to the third parties
- not use the bike for a mountain trips, jumping, stunt tricks, races, etc.
- immediate contact with the employee of the Tourist and Cycling Information Center in case of any problems with the usage of bike and immediate return of the bike
- not repair, modify or exchange any parts of the rented bike
- cover all costs connected with repair or purchase of missing parts of equipment which are fault of the Borrower
- cover all costs of a purchase of a new bike in case of total damage of the rented one.
- 7. In case of loss of the rented bike or its equipment which is fault of the Borrower (including theft), Borrower is obliged to cover costs of the equivalent price of the bike and its equipment (price based on the current prices on the market on the day of the loss).
- **8.** Borrower must follow all traffic laws, signs, rules and regulations while cycling. The Borrower is responsible for all actions while cycling
- **9.** Borrower agrees to cover all fines and penalties of actions against the Polish Law, including Traffic Code.
- **10.** Borrower takes all responsibility for all accidents and all damages and harms, including those done to the third parties while cycling.
- **11.** Borrower renounces all claims towards Tourist and Cycling Information Center which refer to the accidents, harms and injuries done as a result of improper usage of the bike
- **12.** In case of group rental, advanced contact with the employee of Tourist and Cycling Information Center is essential to arrange date, number of bikes and other conditions.

- **13.** Employee of Toursit Information Center can refuse rental of the bike without giving any particular reason.
- **14.** Borrower is obliged to follow Terms and Conditions of bike rental.
- **15.** If returned bike/bikes are considerably dirty, Borrower can be charged additionally for the cleaning service.
- **16.** Bike must be returned by the declared date. Return after the deadline will result in an additional charge, according to the price list.
- 17. Any extensions of bike rental should be reported personally or by phone call + 48 71 346 15 34 to the employee of Tourist and Cycling Information Center in the working hours of the Tourist and Cycling Information Center.
- **18.** In case of not returning the bike by the determined day in the working hours of either Tourist and Cycling Information Center or Bike Cafe, personal data of the Borrower will be passed to the Police with an information about possible indictable offence committed by Borrower.
